

## Boutique and Mid-Sized Law Firms Paying Big Law Salary Scale

In 2018, during what turned out to be the strongest year in the legal market since the Great Recession, Milbank LLP announced a new salary scale for their associates. To stay competitive in the hunt for the best young associates, almost 100 of Milbank's Big Law competitors quickly followed suit. The current Big Law salary scale is:
